1 MS. MILLER: Great. Thanks. Before we continue 2 with the agenda, at the end of today's meeting, we'll meet 3 again in closed session pursuant to Government 4 Code 11126(e)(1) for the purpose of conferring with and 5 receiving advice from our legal counsel on a pending 6 lawsuit. 7 And second, we have the appeal items for 8 San Bernardino City Unified and Lompoc Unified have been 9 withdrawn from this agenda, and finally, the item stamped 10 on pages 42 and 43 of the Consent Calendar for Palo Verde 11 Unified have also been withdrawn from the agenda. 12 So we just decreased the length of this meeting 13 by like half. You're welcome. 14 So first, we go to the Minutes from December 9th. 15 Any changes? Do we have a motion for approval? 16 MR. DIAZ: So move. 17 SENATOR WILK: Second. 18 MS. MILLER: Moved by Mr. Diaz. Seconded by 19 Senator Wilk. Lisa, will you call the roll, please. 20 MS. JONES: Senator Wilk. 21 SENATOR WILK: Aye. 22 MS. JONES: Assemblymember O'Donnell.

1 ASSEMBLYMEMBER O'DONNELL: Aye. 2 MS. JONES: Juan Mireles. 3 MR. MIRELES: Aye. 4 MS. JONES: Cesar Diaz. 5 MR. DIAZ: Aye. 6 MS. JONES: Daniel Kim. 7 MR. KIM: Aye. 8 MS. JONES: Gayle Miller. 9 MS. MILLER: Aye. So we will hold that open and 10 see if a few other members --11 MS. JONES: Great. Thank you. 12 MS. MILLER: -- come and want to add on. Thank 13 you, Ms. Jones. Next, the Executive Officer's Statement. 14 MS. SILVERMAN: Yeah. We have a few things to 15 share with you today. Happy new year, everyone. 16 So we wanted to share with you an update on the 17 priority apportionments which was an action the Board took 18 in September and that was a result of the fall bond sale. 19 So we had nearly \$772 million to award to projects and we 20 can share with the Board that it had update timelines to 21 submit their fund release request to our office by 22 December 24th.

1 We're happy to share that a cumulative total of 2 \$705 million have and will have program -- access to the 3 program cash which is great news. So it's a good draw on 4 the cash. 5 We also wanted to share with the Board there is 6 several projects -- I would say close to 40 -- that have a 7 career tech education program grant. They actually have a 8 different timeline. So they have until September 24th to 9 perfect and come in with their approvals. So that's on a 10 different timeline. 11 So with that, we also wanted to share with the 12 Board there is two projects, \$2.4 million, that didn't come 13 in for the valid fund release request and as a result, they 14 will lose their award again. 15 So the second item we want to share with the 16 Board, if you have an unfunded approval, the requirement to 17 submit a certification to our office was December 12th. 18 That was shortly after our last meeting. So we're happy to 19 report that 274 projects came in for nearly 830 million 20 which is great news for those projects that have unfunded 21 approval. That will deem them eligible for a spring bond 22 So the certifications are valid from January 1st to sale.

1 June 30th of 2020.

I also wanted to highlight the next item is
career tech education program grants. That filing round is
still open and happy to report Mr. Mireles gave us an
update last month that they had over 282 applications that
came through the door for a review.

7 So that's the first step of the process for folks
8 who have not submitted before or wanted a re-review of
9 their application to get a higher score.

So if you have a score of 105 or higher, you have the ability to submit for a funding request, and we're encouraging folks to submit that request through our electronic processing for career tech funding grants.

And so we just also received the first round of scores from the Department of Education, so just great. We're happy the flow bases is working. So we have 70 applications that went through with a score last week and we're eager to see another batch come through and we understand it's probably upwards by 80 projects will have a new score as well.

21 So again, we have a timeline to submit your
22 funding application and your funding application is due to

1 our office in the early part of April, April 6. So let's
2 get them in. There's access to 150 million. Let's get
3 that out the door.

4 The next item I wanted to share with you is that 5 we did share with the Board in December that we're going to 6 have some facility hardship regulation amendments and 7 conversations about how we can refine the process, clarify 8 the program requirements, and we had a meeting on January 9 That was a very successful meeting. We're happy 10th. 10 that we actually produce the documents way before the 11 Christmas break and so folks had an opportunity to review 12 that.

13 Our next meeting is January 31st in this building
14 in 4202 from 9:00 to 11:00. So looking forward to a robust
15 conversation and having more dialogue about the process.

And the last item we wanted to share is as we
start to monitor Prop. 13 and it's getting closer to that
voting date for the election, so we also wanted to share
with the Board that we're putting a planning schedule
together for implementation if the bond does pass.
So we wanted to make it very transparent about

22 what topics we're going to be bringing first, second, and

1 what have you, and our goal is also not only to spread the 2 calendar out with the various topics, but also introduce 3 some of the meetings in various regions throughout the 4 State so folks can have the ability to participate, you 5 know, in Southern California, Central California, the Bay 6 Area, communities up north, and the San Diego area. 7 So again, we're looking forward to produce a 8 document that rolls out the timelines associated with this 9 conversation. So if you're interested in the topic of 10 charter schools or if you're interested in the topic of 11 financial hardship, you'll see in a snapshot of time when 12 those topics will be raised. So it's good information that 13 we want to share. 14 And with that, our next meeting's February 26. 15 MS. MILLER: February 26? 16 MS. SILVERMAN: February 26. 17 MS. MILLER: Great. Thank you very much. Why 18 don't we go ahead -- oh, Mr. O'Donnell, of course. 19 ASSEMBLYMEMBER O'DONNELL: Could we -- for the 20 next meeting, could we agendize an election of the vice 21 chair? Would that need to be agendized or --22 MS. MILLER: It does need to be agendized.

1 ASSEMBLYMEMBER O'DONNELL: So if we could do 2 that, please. And then I know, Madam Chair, you and I 3 talked about this and I don't know whose role this is. So 4 I mean hiring of an assistant executive officer. We've 5 discussed this and that was to be flown, so I don't know if 6 it's been flown or what -- I don't know who handles that. 7 MS. MILLER: The appointment of an executive --8 ASSEMBLYMEMBER O'DONNELL: Assistant -- I believe 9 it's assistive executive officer. 10 MS. MILLER: Assistant executive officer. Yeah. 11 You know, it's a good question, Mr. O'Donnell. The 12 question here is how most efficiently -- of course, first, 13 we need the bond to pass and then there are some questions 14 around how most efficiently to get feedback from the 15 community and from stakeholders. 16 So I think -- we did reach out to your office for 17 a meeting. I know you'd rather do that here. So I --18 ASSEMBLYMEMBER O'DONNELL: Okay. We had a 19 meeting. You and I discussed this --20 MS. MILLER: Right. And then I wanted to --21 ASSEMBLYMEMBER O'DONNELL: My understanding is 22 that it was going to be flown. And I -- the perception --

1 MS. MILLER: Tell me what you mean by flown. 2 ASSEMBLYMEMBER O'DONNELL: Flown meaning there's 3 a position open. There is the title --4 MS. MILLER: No. I think the discussion we had 5 was that I actually didn't know there was an assistant 6 executive officer. 7 So certainly I think what we want to do is make 8 sure that the information we get from stakeholders around 9 the state is complete and can actually be implemented and 10 used and useful. 11 So what I'm trying to do and make sure I 12 understand is the past experiences, which I don't think 13 have always been as effective as we had hoped in terms of 14 actually delivering what the bond and the statute intended, 15 so -- excuse me. 16 So I think that's sort of the stakeholder process 17 that we really want to consider is that there is very 18 specific statute -- again, AB-48 is now a bond and has to 19 be approved -- and what that looks like going forward I 20 think is an important discussion and happy to agendize it 21 and discuss it next month. 22 ASSEMBLYMEMBER O'DONNELL: Okay. I'm a little

1 confused by that, but either way, are you talking about the 2 implementation --3 MS. MILLER: Well, I'm talking about two things. 4 So there's two --5 ASSEMBLYMEMBER O'DONNELL: So there's some 6 concern in the community about implementation of AB-48 7 should it pass. 8 MS. MILLER: Um-hmm. 9 ASSEMBLYMEMBER O'DONNELL: And is that where 10 you're coming from? 11 MS. MILLER: Well, I think there are two reasons 12 for --13 ASSEMBLYMEMBER O'DONNELL: We talked about in the 14 implementation committee. 15 MS. MILLER: Right. 16 ASSEMBLYMEMBER O'DONNELL: So something of that 17 sort, is that where you're going --18 MS. MILLER: No. I'm talking about I think 19 there's two discrete issues. There is this -- the idea of 20 this assistant executive officer --21 ASSEMBLYMEMBER O'DONNELL: Um-hmm. 22 MS. MILLER: -- which is -- which we'll put on

1 the agenda for next time. 2 ASSEMBLYMEMBER O'DONNELL: Um-hmm. 3 MS. MILLER: There is also the issue of electing 4 a vice chair which you've also asked to be agendized for 5 next month. 6 ASSEMBLYMEMBER O'DONNELL: Um-hmm. 7 MS. MILLER: And then there's the issue of --8 ASSEMBLYMEMBER O'DONNELL: Well, the vice chair -9 - just quickly -- is part of the rules and operating 10 procedures. We should have elected one already. 11 MS. MILLER: And we've added that to the agenda 12 for next month --13 ASSEMBLYMEMBER O'DONNELL: Yeah. 14 MS. MILLER: -- at your request. 15 ASSEMBLYMEMBER O'DONNELL: And the other one I 16 think may entail some more discussion. 17 MS. MILLER: Right. And add to your point, there 18 are two discussion pieces to that. One is the executive 19 officer, which I think is a robust discussion because it 20 did not always lead to actually implementing the statute. 21 So we want to be really mindful of that. 22 And two along with that is an implementation

1 committee should this bond measure pass. So happy to 2 agendize all of that and we'll have that discussion in 3 February. Thank you. 4 Okay. With that, can we move to the Consent 5 Calendar, please. 6 MS. SILVERMAN: Yeah. Consent Agenda is ready 7 for your approval. 8 MS. MILLER: Thank you. And just to repeat, 9 there were two items removed from the Consent Agenda. With 10 that, do we have a motion and a second. 11 MR. DIAZ: So move. 12 ASSEMBLYMEMBER O'DONNELL: Second. 13 MS. MILLER: Moved by Mr. Diaz, seconded by 14 Mr. O'Donnell. Ms. Jones, will you please take the roll. 15 MS. JONES: Certainly. Senator Wilk. 16 SENATOR WILK: Aye. 17 MS. JONES: Senator Leyva. 18 SENATOR LEYVA: Aye. 19 MS. JONES: Assemblymember O'Donnell. 20 ASSEMBLYMEMBER O'DONNELL: Aye. 21 MS. JONES: Assemblymember Cunningham. 22 ASSEMBLYMEMBER CUNNINGHAM: Aye.

1 MS. JONES: Juan Mireles. 2 MR. MIRELES: Aye. 3 MS. JONES: Cesar Diaz. 4 MR. DIAZ: Aye. 5 MS. JONES: Daniel Kim. 6 MR. KIM: Aye. 7 MS. JONES: Gayle Miller. 8 MS. MILLER: Aye. 9 MS. JONES: Motion carries. 10 MS. MILLER: Thank you very much, Ms. Jones. 11 Moving onto the financial reports, Ms. Silverman. 12 MS. SILVERMAN: Yes. I just wanted to highlight 13 on page 71, just the update on the fund release request. 14 We had over \$133.2 million of funds being disbursed in 15 November and December. So that's great news. 16 And as far as the activity on page 73 with the 17 status of funds, although we didn't have a lot of flow of 18 unfunded approvals going this month and there's a reason 19 why is because if we have a construction cost index 20 adjustment, we want to bring all those projects back to a 21 February board so we're not doing over some of the unfunded 22 approvals.

So with that, we do have some closeout activities
that we want to share and some rescissions. So we have
over \$1.3 million that reflected an adjustment to some
program grants and some closeouts and that represents for
six projects, and we have over \$306,000 for 14 projects
that represent rescissions.

7 And we also have some adjustments for full-day
8 kinder, so for those folks who had an amendment to their
9 grants for the prior approval. So we wanted to share with
10 the Board on page 74 that activity did reflect and the
11 posting of the status of funds. So with that, I'm happy to
12 answer any questions.

MS. MILLER: Okay. Thank you. Any questions?
No. Thank you. Any public comment? Great. Thank you.
We will now move onto the appeal items, and we -San Bernardino and Lompoc were both withdrawn from today's
agenda, just for anyone that wasn't here for that.

18 So with that, we will move to the Washington19 Unified and Fresno appeal.

20 MS. SILVERMAN: So, yeah, I'd like to share with
21 the Board, on page 163, grab your attention -- so with
22 that, we wanted to highlight some significant facts

1 regarding this project.

We had -- American Union Elementary School came
in initially for its program grant back in June 2010, and
at the time, they were eligible for financial hardship
status. And the issue here before you is whether or not the
district who subsequently unified to Washington Unified
should have to return excess program grants as a result of
receiving a design award.

9 So there was \$234,000 that was received twice as
10 a result of us processing their grant approval. So I just
11 want to highlight to the Board, in June, the Board did
12 approve that grant request in June of 2010 and that was
13 under American Union Elementary School and that was for an
14 elementary school project.

15 Subsequently to that event, the district came in 16 for its apportionment in December of 2010. However, on 17 July 1st of 2011, the district went through a unification 18 process in which they unified with American Elementary 19 Unified with West Fresno Elementary School. They also 20 unified with Washington Union High School District. 21 So they became -- the new title of the district 22 became Washington Unified. Subsequent to that event in

September of 2011, the district came in with their funding
 request for that project at the elementary school and with
 that, staff had challenged whether or not they could
 actually come in for that grant.

5 That was subsequently resolved in March -- excuse 6 me -- in August of 2012, in which the district had appealed 7 their status for financial hardship and they were granted 8 hardship status based on that original project at American 9 Union Elementary School.

So with that, the district did -- we did process an unfunded approval for that program grant at the elementary school. We awarded over \$2.4 million for that program grant and as a result of processing that program grant, we actually processed the design grant again with that full grant.

So as we go through the closeout process -- we did subsequently release the funds. We went through the closeout process when the district was determining how much expenditures were eligible for the project. We actually submitted to the district that they had savings associated with that financial hardship project and so they had over \$99,000 of savings they needed to return.

| 1 | And the district was notified in December of | | | |

| 2 | 2017. In January of 2018, the district did agree and | | | |
| 3 | concur with those findings. Several weeks after that, | | | |

| 12 | So the district agrees to return the 99,000. | | | |
| 13 | However, they don't concur that they have to return the | | | |
| 14 | \$234,000. They admit that, you know, because the staffing | | | |
| 15 | error and obviously, it's probably the one off occasion | | | |
| 16 | that it did happen, but it was a rare occurrence. | | | |
| 17 | But they definitely built the project in | | | |
| 18 | accordance to the program budget that they received in | | | |
| 19 | their award. | | | |
| 20 | So with that, staff also wanted to recognize the | | | |
| 21 | regulations for financial hardship as receiving the | | | |
| 22 | advanced design under 1859.81.1, the program does allow for | | | |
| | | | | |

1 an advanced design up to 40 percent of the construction
2 grant.

However, the regulation also specifies that the
grant needs to be reduced once they came in for the full
project. So in essence, staff should have reduced the
project when it came in for the full funding.

7 And as a result, staff does acknowledge the error
8 and it was likely dealt with the merging of the three
9 districts. We're unaware of any other circumstances where
10 we had appropriated design funds twice.

If I can direct your attention on page 166, I
want to share with the Board the table of the project
funding. So the total award for the district that included
the double funding for the design grant was \$2.7 million.

15 The expenditures as audited was over \$2.6 million
16 and so the net result initially was the \$99,000 to be
17 returned. But as we, like I said, reconciled the program
18 grant, that grant actually should have been reduced and so
19 the true award should have been over \$2.4 million.

20 And so even though the expenditures were over
21 \$2.6 million and they're a hardship district, there's
22 \$134,000 that was overspent on the project. The true

1 return of the project should be that additional grant --2 design award. So that \$234,178 should -- the district 3 is -- staff would ask the district to return the funds. 4 So at this time, we have no program regulations 5 that obviously would waive that additional grant. So we're 6 seeking Board direction. 7 MS. MILLER: Okay. And Ms. Silverman, if we can 8 just clarify, it's the 234,178 that you're asking for and 9 of that, they've agreed to return the 99,000 --10 MS. SILVERMAN: That's correct. 11 MS. MILLER: -- as well, so --12 MS. SILVERMAN: Yeah. 13 MS. MILLER: -- the net is like 135,178, right? 14 MS. SILVERMAN: Yeah. The district has claimed 15 that they have the 99,000 available in their accounts to 16 return. So in essence, they have the funds to pay some of 17 the project, but I guess the contentious issue is we 18 haven't received the funds back. 19 So that's really at play. So they would have to 20 pay an additional \$134,000. 21 MS. MILLER: Right. 22 MS. SILVERMAN: That's correct.

1 MS. MILLER: Thank you. Senator. 2 SENATOR LEYVA: If I could just make a comment. 3 You know, the 99,000, if they have that and can pay it 4 back, this is through no fault of their own. It was a 5 mistake and, you know, it happened, what, ten years ago. 6 So we hate to see kids suffer now and have that additional 7 monies -- they might not even have the money. So we don't 8 know how they would get it. So I would certainly be 9 supportive of them paying back what they have, which is the 10 99,000 and if you need a motion, I'll make a motion. 11 MS. MILLER: Thank you. I appreciate that. So 12 it's been moved. Is there any public comment --13 ASSEMBLYMEMBER O'DONNELL: Second. 14 MS. MILLER: Second by Mr. O'Donnell. Anyone 15 here from the district? No. Oh, would you like to come 16 up, sir? 17 MR. MOORE: Sure. 18 MS. MILLER: Thank you. If you could please 19 state your name for the record. Thank you. 20 MR. MOORE: My name is Randy Moore. 21 MS. MILLER: Oh, sir, do you mind speaking at the 22 mic.

1 MR. MOORE: Yes, sir. 2 ASSEMBLYMEMBER CUNNINGHAM: I just had one 3 question for you. So the \$134,508.69, which is the 4 difference between the 99- you're agreeing to return what 5 is recommended that you return, right? Is that -- was that 6 money spent or is it sitting somewhere? 7 MR. MOORE: Spent. 8 ASSEMBLYMEMBER CUNNINGHAM: Okay. And what did 9 it get spent on? 10 MR. MOORE: My understanding is it was spent on 11 the project at American Union. 12 ASSEMBLYMEMBER CUNNINGHAM: So for you to return 13 the full 234,178, you would have to find an additional 14 134,508. 15 MR. MOORE: Correct. 16 ASSEMBLYMEMBER CUNNINGHAM: Okay. That's all I 17 have. 18 MS. MILLER: Thanks, Mr. Cunningham. 19 Mr. Nazarian. 20 MR. NAZARIAN: Thank you. Thank you for being 21 here, first of all, and I appreciate that you brought this 22 issue forward because it also is an exercise for us to go

My concern was it's not the amount of money.
Obviously, if it's put to good use, it's well worth it and that's not an issue and I think on many occasions before
we've voted to grant the appeal of a school district in
similarly situated circumstances.

7 But in this case, I'm just wondering if the
8 district had received the funding twice -- maybe you can't
9 speak to this because it's before your time --

MR. MOORE: Yes. Sure.

MR. NAZARIAN: -- but there would be a fiduciary obligation of the district also notifying the Board that there was two sets of similar funding for the same project given to them, and so one of -- was there in error. Was there ever a conversation about that?

MR. MOORE: You know what, I can't really speak to that because I wasn't there during that time. My -after figuring out why I needed to come here today and trying to understand how we got to this point, my understanding was that there was definitely some confusion during the unification process and during that unification process, there was also a building of an administration for

1 the unified district because it wasn't like American Union 2 joined a unified district. 3 American Union, West Fresno, and Washington Union 4 unified at the same time. And so my understanding is that 5 the district did not realize when the unified district came 6 and got the apportionment that there was an additional 7 design fee that was already issued to American Union. 8 MR. NAZARIAN: But that merger also helped the 9 collective of the school districts. 10 MR. MOORE: Correct. 11 MR. NAZARIAN: Okay. If you can't answer this, 12 I'm not going to belabor the point. 13 MR. MOORE: Sure. 14 MR. NAZARIAN: But I -- there's many things that 15 I'm willing to support --16 MR. MOORE: Sure. 17 MR. NAZARIAN: -- but when it comes to something 18 like this, I feel like it sets -- or sends a wrong message, 19 so I'm going to be withholding my support for this. 20 MR. MOORE: Okay. 21 MS. MILLER: Thank you, Mr. Nazarian. Mr. Kim. 22 MR. KIM: Thank you, Superintendent, for coming

1 here and I understand you weren't there at the time, but 2 this is hardship funds. So there wasn't a district match 3 for this project, was there? 4 MS. SILVERMAN: No --5 MR. KIM: So what I'm not understanding is if 6 this was for the design fee and you spent the money or at 7 least 134,000 than you expected, that means there was a 8 cost overrun and shouldn't that have been reported in some 9 way or fashion. That's one thing -- or two -- and that 10 would be a huge increase to the design fees compared to 11 what they would have only gotten. 12 Or two, that money was spent on something else 13 that wasn't part of this project once it's been 14 (indiscernible). So I'm just trying to reconcile how did 15 this -- where did this money go. I know you spent it. On 16 what? 17 MR. MOORE: Sure. Well, in the research that I 18 was able to do, it was spent on a project at American Union 19 as far as I can tell. 20 MR. KIM: But wouldn't you be able to identify 21 where the cost overrun was? Someone would have been able 22 to identify, yeah, we overspent in this line item.

1 MR. MOORE: It was not brought to my attention 2 until it came from this office that we had been issued the 3 design phase twice. 4 I think part of the issue was that MS. MILLER: 5 three districts were consolidating at one time, but you 6 could speak to this much better than me. 7 MR. MOORE: Yeah. I mean the unification 8 process, while I wasn't there at the time, I've become 9 really familiar with it because I live in the area and was 10 part of it from the public sector, if you will. 11 That process -- so actually, West Fresno --12 American Union put it to the voters, right? And they said 13 the Board decided. The voters got to decide on 14 unification. West Fresno, that wasn't the case. 15 West Fresno was -- what is the proper term, 16 Chris? Chris, do you know the proper term for West Fresno? 17 Laxation (ph). Thank you. Laxated (ph) into the district 18 once American Union became part of it. So while I'm not 19 familiar with the internal interactions and how things got 20 communicated on all levels, it was a very different view 21 for a community that had six separate school districts 22 operating independently for the entirety of their

And that would 3 increase the developer fees to \$4.08 for residential and 4 \$0.66 for the commercial. 5 We also have put a footnote on this item just to 6 draw folks' attention to the fact that if Proposition 13 7 does pass, there are provisions in AB-48 that would 8 potentially change who pays the developer fee, what types 9 of development with respect to multi-family housing and 10 location to transit stops. 11 So that would become effective if the bond 12 passes. So we just wanted to draw attention to that today, 13 but no action needed on that piece today. We're just 14 asking the Board to adopt the typical every two-year change 15 to the level one fees. 16 MS. MILLER: Great. Thank you very much, 17 Ms. Kampmeinert.
